Civil

Almost 1/3 of civil cases were disposed by default judgment, while almost 1/10 were settled.

Almost 2/5 of Administrative Review and 1/3 of Small Claims cases went to bench trial.

About 2/5 of Real Estate and 1/3 of Contract cases were disposed by default judgment.

Over 2/3 of Tort cases were dismissed.

Domestic Relations

Over 2/5 of domestic relations cases were settled, while almost 1/5 went to bench trial.

Over 4/5 of Marriage Dissolution and almost 1/2 of Modification and Paternity cases were settled.

More than 1/2 of Adult Abuse cases were dismissed.

Over 1/5 of Adult Abuse and Modification cases went to bench trial.

Criminal

Three-fourths of criminal cases were disposed by a guilty plea, while 1/5 were dismissed.

Over 2/3 of Circuit Felony trials resulted in a finding of guilt.

Almost 9/10 of Circuit Felony and Traffic cases resulted in a guilty plea.

Over 1/2 of Misdemeanor cases resulted in a guilty plea.

Over 2/5 of Misdemeanor cases were dismissed.
